I am writing on behalf of the board and members of Admiralty Audubon Society to convey our enthusiastic support for the Puget Sound to Pacific (PS2P) FY23 RAISE application. This application seeks support to advance the cross-nation Great American Rail-Trail in Western Washington State. Support is requested for planning purposes, to develop pathways to fill missing links; provide for community connections; and improve design, safety and ecological restoration to complete this visionary trail.

In crossing the Kitsap and Olympic Peninsulas, the proposed trail extends between the Strait of Juan de Fuca and Olympic National Park, a World Heritage Site. These natural assets attract visitors from around the world and provide a foundational portion of our local economy.

While the natural beauty of this region has attracted high-end homes for retirees and telecommuters, median incomes provided by local jobs within rural Jefferson County remain well below the Washington State average. Attracting active transportation visitors would provide important new economic opportunities for our region. A continuous trail across this region would provide connectivity to expand the experience of this spectacular landscape via hiking and bicycling while minimizing emissions of greenhouse gases.

Admiralty Audubon Society was founded in 1977 as part of the successful effort to establish the Protection Island National Wildlife Refuge. This island is in the Strait of Juan de Fuca adjacent to our northern coastline and provides the majority of safe nesting areas for ground-nesting marine birds in the entire Puget Basin region. It is critical to local populations of such species as the Tufted Puffin, Rhinocerous Auklet, and Pigeon Guillemot. Establishing the proposed wildlife corridor and continuous trail for hiking and biking for wildlife viewing builds on this legacy while minimizing impacts.

The proposed PS2P trail also links to and incorporates the Larry Scott Trail, a multiuse trail that in part utilizes the retired Milwaukee Railway route. This trail is not yet fully complete but the completed sections terminate in Port Townsend at the Kah Tai (qatáy) Lagoon Nature Park. This 76+ acre park includes the approximately 34 acre lagoon that remains of the original, tidally-flushed coastal lagoon. Admiralty Audubon Society adopted the park 22 years ago and has established native plants that have enhanced bird habitat, viewing opportunities and provides enhanced resiliency to climate change related stresses to both local urban wildlife and migratory bird species of the Pacific Flyway.

Importantly, Kah Tai Lagoon represents the southern terminus of a portage route used by Indigenous peoples for millennia to cross the Quimper Peninsula and avoid the treacherous currents at Point Wilson. Translated, Kah Tai means "portage" or " place where we meet." To celebrate and acknowledge the heritage of the Indigenous peoples, Port Townsend community members have developed the Chetzemoka (čičməhan) Trail. This trail directs walkers and bikers to 18 locations within the City of Port Townsend of special importance to tribal history. Kah Tai Lagoon is one such location and Admiralty Audubon Society maintains a marker and bench in support of this effort. Passing this location, one is reminded of whose historic lands you are on and of their rich history.

In summary, development of this trail would 1) respect and honor Indigenous heritage, 2) support and develop further appreciation for wildlife and natural beauty while minimizing greenhouse gas emissions, 3) promote active outdoor activities, and 4) enhance the economic opportunities of rural East Jefferson County. This application has our full and enthusiastic support.

This united community initiative purchased 3,500 acres of industrial forest land for conversion to more diverse climate and habitat-friendly forest in what is now the Port Gamble Forest Heritage Park. And recently our community purchased 756 acres of timber rights to preclude future clear cut harvest. A mile of the recent timber rights purchase provides a 600 foot wide buffer of older trees, for example, along the Sound to Olympics Trail.

And, Kitsap Audubon was an active partner in the year long Steering Committee to create Kitsap Park Department's Master Plan for this Port Gamble Park. Guidelines developed call for re-purposing six miles of existing logging roads, which are now signed as the STO.

We at KAS also want to share with you the high value we place on inclusiveness, so that people of all ages and abilities, cultural heritage, and economic means can share the benefits of being in nature. Our Equity, Diversity, and Inclusion Committee is very much concerned with assuring that people with mobility challenges have facilities to make that possible. Thus we very much support the STO, and all of the PS2P to provide the surfaces that work for people using wheelchairs and other assistive devices, which are inherent to the shared-use path standard for such regional trails.

An example of our commitment was hosting Virginia Rose, Founder and President of Birdability as featured speaker at Audubon Washington's statewide annual meeting this past Spring.

Ian's Ride focuses on improving and promoting outdoor accessibility for those with mobility impairments. This is accomplished by offering year-round group trail rides for individuals who use mobility aids. We also consult with local agencies on how to maximize the accessibility of outdoor spaces. Finally, we demonstrate that people with disabilities are an important user group of outdoor accessible infrastructure.

Our flagship event is called Sea to Sound. It offers people of all abilities and modes of transport a chance to travel 75 miles over three days along the iconic Olympic Discovery Trail. It's a unique opportunity for people in the disability community to experience the outdoors in a fully supported way. Last year was the fourth year of the event and we had over 100 participants and one third had mobility impairments. The interactions and experiences individuals take home from these events are transformative and positive for the community.

The suggested route for the PS2P is an ideal way to provide access for individuals who utilize wheelchairs to safely travel between the greater Seattle area to Bainbridge Island and on to the Olympic Peninsula. In 2018 our founder, a C3 quadriplegic took a wheelchair from Idaho to Port Angeles to demonstrate the need for more accessible infrastructure. Many other wheelchair users joined along the way. It was very challenging finding a safe route for a wheelchair to travel between Seattle and Port Angeles. We were forced onto the side of highways and busy roads. This proposed infrastructure would allow all users to travel this route in a safe way.

Outdoor recreation can be difficult for people who rely on mobility aids such as wheelchairs, walkers, scooters and other devices to navigate the world. A quiet place to explore nature in a safe way is highly sought out but often difficult to find. The large community of wheelchair users in the Puget Sound region would greatly benefit from a complete trail system from the Puget Sound to the Pacific. This ribbon of trail would be easily accessible for a vast number of adapted users.

Multiuse trails, like the proposed PS2P, are extremely important for the disability community. Rail trails by their very nature are usually accessible. These throughways allow for outdoor recreation, safe commuting, access to nature and social opportunities. They are also exemplary ways to unite and connect communities. Utilizing a common infrastructure for commuting or recreation creates opportunities for interactions with people of all abilities and demographics.

I advocate for trails such as the Sound to Olympic Trails because I have seen the effects of similar trails, both in other areas of the U.S. and abroad. Not only do trails like the PS2P offer community members an alternative, safe, healthy and sustainable mode of transportation, they can help bolster the local economies of the all the areas they connect. Gravel cycling has exploded in recent years and areas with substantial trails, like the PS2P, have become destinations for riders from all around the country and beyond.
